Excellency,

Upon instructions from my Government, and further to our letters dated 3, 7, and 9 March 2026 (S/2026/121—S/2026/139—S/2026/146), I wish to inform Your Excellency and the members of the Security Council of the following:

As stated in the above-mentioned letters, the United States of America and the Israeli regime carried out an attack against the Islamic Republic of Iran on 28 February 2026 in contravention of the fundamental principles and rules of international law, including the principle of the prohibition of the use of force and the peremptory norm prohibiting aggression against the Islamic Republic of Iran. In the course of this cowardly act of aggression, the facilities, territory, and airspace of certain neighboring States in the region have been placed at the disposal of the aggressors for the commission of acts of aggression against the Islamic Republic of Iran.

According to the monitoring conducted by the Armed Forces of the Islamic Republic of Iran, the aggressors have utilised the territory and airspace of the Sultanate of Oman for the planning, preparation, equipping, and carrying out of unlawful military attacks against the Islamic Republic of Iran since the beginning of the war. Certain recent instances thereof are set forth as follows:

- At 00:20 on 12 March 2026, a United States U-2 reconnaissance aircraft, present over the airspace of the Sultanate of Oman, provided intelligence support to United States fighter aircraft;
- At 04:21 on 12 March 2026, a United States U-2S reconnaissance aircraft, present over the airspace of the Sultanate of Oman, provided intelligence support to United States fighter aircraft;
- At 05:26 on 12 March 2026, a United States RQ-4 UAV, by utilising and transiting through the airspace of the Sultanate of Oman, entered the southern airspace of the country from



the southern part of the Persian Gulf and undertook reconnaissance of targets within the territory of the Islamic Republic of Iran;


- At 06:48 on 12 March 2026, a United States RQ-4 UAV, by utilising and transiting through the airspace of the Sultanate of Oman, entered the southern airspace of the country from the southern part of the Persian Gulf and undertook reconnaissance of targets within the territory of the Islamic Republic of Iran; and
- At 17:08 on 13 March 2026, a United States F-18 fighter aircraft, by utilising and transiting through the airspace of the Sultanate of Oman, proceeded to bombard targets within the territory of the Islamic Republic of Iran.

In view of the foregoing, the Islamic Republic of Iran calls upon the Sultanate of Oman to prevent the continued use of its territory against the Islamic Republic of Iran.

The Islamic Republic of Iran remains committed to maintaining friendly relations with the Sultanate of Oman based on mutual respect, the principle of good-neighbourliness, and respect for each other's sovereignty and territorial integrity

I should be grateful if you would have the present letter circulated as an official document of the Security Council.
