Excellency,

Upon instructions from my Government, and pursuant to my letters dated 3, 7, 9 and 16 March 2026 (S/2026/121, S/2026/139 and S/2026/146), and in response to letters from the Permanent Mission of the State of Qatar to the United Nations addressed to the President of the Security Council, including the letter dated 17 March 2026 (S/2026/195), I wish to inform Your Excellency and the members of the Security Council of the following:

As of the commencement of the unlawful military aggression against the Islamic Republic of Iran on 28 February 2026 and continuing to the present, the territory of the State of Qatar and other neighbouring countries has been used by the aggressors to launch their attacks against Iran. The unlawfulness of placing its territory at the disposal of the aggressors, as an internationally wrongful act, and the international responsibility arising therefrom have been brought to the attention of the officials of the State of Qatar and circulated as an official document of the Security Council.

It is noted that, as a result of the internationally wrongful act of assistance by the State of Qatar to the aggressors, they have been able to target thousands of civilians and civilian objects in the Islamic Republic of Iran. This is taking place in manifest disregard of the principles of mutual respect and good neighbourliness. All damage and loss resulting from these unlawful actions are currently under assessment by the competent authorities, which will duly notify and provide updates as further developments arise.

As per the latest monitoring and assessments conducted by the armed forces of the Islamic Republic of Iran, the territory and airspace of the State of Qatar continue to be utilised by the aggressors for the purpose of carrying out military attacks against the Islamic Republic of Iran.

In the exercise of its inherent right of self-defence, the Islamic Republic of Iran considers that any military bases and facilities of the aggressors, where used for launching or supporting



armed attacks against its territory, may constitute legitimate military objectives, and reserves the right to take necessary and proportionate measures to prevent further loss of civilian life and damage.

Once again, it must be reiterated that the Islamic Republic of Iran has consistently respected its long-standing friendly relations and the principle of good neighbourliness with the State of Qatar. Regrettably, this principle has not been observed by the State of Qatar, which has allowed the United States of America to launch and continue armed attacks against the Islamic Republic of Iran from its territory. The internationally wrongful acts of the State of Qatar entail its international responsibility.

I should be grateful if you would have the present letter circulated as an official document of the Security Council.
