Excellency,

Upon instructions from my Government, and with reference to my previous letters, including those dated 3, 7, 9, 16, 26, and 30 March 2026 (S/2026/121, S/2026/139, S/2026/146, S/2026/188- S/2026/231 and S/2026/247), and with to the letter from Permanent Representative of the State of Qatar addressed to President of the Security Council dated 30 March 2026 (S/2026/256), I wish to inform Your Excellency and the members of the Security Council of the following:

Based on monitoring and assessments conducted by the Armed Forces of the Islamic Republic of Iran, it has been ascertained that the aggressor, namely the United States, has continued to use the territory and airspace of the State of Qatar for the planning, preparation, equipping, and execution of unlawful military attacks against the Islamic Republic of Iran. Some specific instances are as follows:

- At 07:37 on 18 March 2026, United States F-35 fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;
- At 17:20 on 18 March 2026, United States F-16 TUR fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;
- At 01:49 on 22 March 2026, United States F-35 fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;
- At 11:31 on 22 March 2026, United States F-35 fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;



- At 20:21 on 23 March 2026, United States F-35 fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;
- At 22:50 on 23 March 2026, United States B-1 bomber aircraft, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;
- At 18:58 on 25 March 2026, United States F-35 fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;
- At 22:45 on 25 March 2026, United States P-8A maritime patrol and reconnaissance aircraft, utilising and transiting the airspace of the State of Qatar, provided intelligence support to United States fighter jets;
- At 20:26 on 26 March 2026, United States F-15E fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran;
- At 05:05 on 26 March 2026, United States RQ-4-USA reconnaissance drone, operating over the airspace of the State of Qatar after entering from the south of the Persian Gulf, conducted reconnaissance and identification of targets inside the territory of the Islamic Republic of Iran; and
- At 17:02 on 26 March 2026, United States F-35 fighter jets, utilising and transiting the airspace of the State of Qatar, carried out bombing raids on targets inside the Islamic Republic of Iran.

In light of the international responsibility of States arising from placing their territory at the disposal of others for the commission of acts of aggression and the conduct of armed attacks against the territory of a third State, the Islamic Republic of Iran expresses its strong and unequivocal objection to the aforementioned unlawful actions and strictly calls upon the State of Qatar to observe the principles of good neighbourliness and to prevent the continued use of its territory against the Islamic Republic of Iran.



The Islamic Republic of Iran, while remaining committed to the principle of good neighbourliness and to respect for the sovereignty of the State of Qatar, reserves its inherent right to take all necessary and appropriate measures, including the exercise of its right of self-defence, in order to safeguard its sovereignty, territorial integrity and political independence.

I should be grateful if you would have the present letter circulated as an official document of the Security Council.
